Do dumping and countervailing duties still apply in Australia?

Dumping and countervailing duties still apply to goods imported from countries with which Australia has free trade agreements. Anti-dumping and countervailing measures are imposed where Australian manufacturers are being materially injured by dumped or subsidised imports.

Are China's anti-dumping claims outside the panel's terms of reference?

Australia thus argues that China's claims (whether regarding anti-dumping or countervailing measures) as they pertain to the superseded segments (i.e. original investigations and interim reviews) are outside the Panel's terms of reference. The second pertains to China's CVD claims which operate as against Program 1.

Did Australia violate the Anti-Dumping Agreement?

7.152. China claims that Australia violated Article 2.2.1.1 of the Anti-Dumping Agreement because the ADC failed to calculate relevant costs "on the basis of records kept by the exporter or producer under investigation" within the meaning of Article 2.2.1.1.

Did Australia impose final anti-dumping and countervailing duties on stainless steel sinks?

By way of notices dated 19 March 2015, the Parliamentary Secretary to the Minister for Industry and Science of Australia imposed final anti-dumping and countervailing duties in respect of stainless steel sinks imported into Australia from China.

Simply put, the Government of China was found not to have unfairly influenced the price of solar panels being imported into Australia - so strike item 1 off the dumping claim for now.
