Bhutan's National Energy Policy 2025 (NEP 2025), released in June 2025 by the Ministry of Energy and Natural Resources (MoENR), represents a pivotal shift in the country's energy strategy.

What is the power demand in Thimphu?

exhibits the growth potential and power demand of the various localities in Thimphu. estimated within the next 10 years. The area-wise power planning as per the projected load is as to grow over (to) 9.83 MW and 2.09 MW respectively. Currently, the power requirement to those areas is catered via (from) 2x5 MVA, 33/11 kV substation at Babesa.

Who is responsible for energy policy in Bhutan?

The Ministry of Energy and Natural Resources set up the Department of Energy as the policy-making body after merging two departments, the Department of Hydropower and Power Systems, and the Department of Renewable Energy. Bhutan's energy sector operations have separate commercial management and ownership from the government.

What is Bhutan's energy security & sustainable growth policy?

Titled "Empowering Energy Security & Sustainable Growth," the policy consolidates and supersedes several prior frameworks, including the Bhutan Sustainable Hydropower Development Policy 2021, Alternative Renewable Energy Policy 2013, Domestic Electricity Tariff Policy 2016, and National Energy Efficiency & Conservation Policy 2019.
