Are there false claims against solar development?

The false claims assessed in the report cover a wide variety of arguments against solar development. These include factually inaccurate arguments related to human health, the environment, agriculture, economics, reliability and technological limitations.

How many false claims about solar energy are there?

Earlier this April, the Sabin Center for Climate Change Law at Columbia University published a new report, "Rebutting 33 False Claims About Solar, Wind, and Electric Vehicles," that identifies and assesses 14 of the most pervasive false claims about solar energy, along with 19 other false claims about wind energy and electric vehicles.

Why did the EPA cancel a \$7 billion solar program?

During the Trump administration, the Environmental Protection Agency canceled a \$7 billion program aimed at making solar power accessible to low-income households.

Why does solar power not always happen?

However, it ignores the reasons why this does not always happen, namely the limited availability and suitability of such land, the cost of developing it for solar power and the fact that this may be in competition with other uses, such as new housing.
